

## GENTERA ACQUIRES 100% OF COMPARTAMOS FINANCIERA'S SHARES IN PERU

**Mexico City, March 23, 2015-** GENTERA, S.A.B. de C.V. (BMV: GENTERA\*) announced today the acquisition of the remaining 15.79% shares of Compartamos Financiera (formerly "Financiera CREAR"). With this transaction GENTERA owns 100% of Compartamos Financiera's shares. The transaction amounted approximately US\$27 million dollars.
